- A new industrial oven and industrial mixer were purchased for the kitchen.
 Both improve the efficiency of food production as well as the diet and quality of food for residents.
- Unfortunately, covid has resulted in some planned projects being put on hold.

The impact of covid on the nursing home operations has been significant. It has brought forth many additional mandatory procedures within the home. Labdara is very fortunate to have the outstanding leadership of our administrator, Laura Puteris, who competently and efficiently addresses
